1. Submit completed application to the Intergroup Office no later than August 15, 2022
2. Each applicant must have a home group and a sponsor.
3. Because of the time commitment, it is suggested that you discuss this service opportunity with your family and AA sponsor. (4-6 hours per month)
4. You will be expected to: attend all Board and Intergroup Representatives (“Full Council”) meetings; serve on a board subcommittee; and participate in functions that are sponsored by Wilmington Area Intergroup (e.g., Founder’s Day picnic, Alkathons, etc.)
5. Your Home Group should be located within the service confines of the Wilmington Area Intergroup (i.e., New Hanover, Brunswick, Pender or Columbus counties).
6. The Intergroup Bylaws require each candidate to have eighteen (18) months of continuous sobriety on the date the election is held.
7. A business background can be helpful. However experience at your Home Group, Intergroup, or General Service brings value to the mission of Wilmington Area Intergroup. Our Bylaws provide that candidates must have served previously or is currently serving as an Intergroup Rep. or General Service Rep.
8. No more than two (2) members from the same Home Group can serve on the board at the same time.
9. As an elected board member you are serving all the groups in the Wilmington Area AA community not just your AA Home Group.
10. There are six (6) two (2) year term openings that begin January 1, 2023 and end December 31, 2025.
11. The six (6) candidates with the highest number of votes are elected. In case of a tie, a second and third vote will be held and in case of a continued tie the names will be drawn from a hat.
12. Wilmington Area Intergroup is a North Carolina 501 (c) (3) non-profit corporation and is subject to all State and Federal laws.
13. The Intergroup Bylaws require that copies of all submitted applications be sent to the Intergroup Representatives of record 14 days prior to the annual election. These will be sent electronically where possible.
14. The Board elections are held annually at the Full Council meeting, the 2nd Saturday in September. This year that date is September 10, 2022..
15. Full Council meetings and annual elections begin at 4:00 PM and are virtual.
